# Business carried forward from previous meeting(s):

- [Mossman]: Appointment of BOD Member for Professional Issues: *Max Farley has accepted the remainder of the role.*
- [WADE] Motion needed to rescind BOD action from last meeting to revise by-laws to establish a category for Honorary Life Member. By-laws review shows we already have a category for Honorary Member, and once an honorary member, one is an honorary member for life. Banks informed that he can move forward with his plan to confer honorary membership status on Betty Soskin and associated media notifications. Shannon moved to rescind, Troy seconded, no discussion, passed unanimously.
- [Mossman]: ANPR Citizens Award: No progress this past month
- [DeGennaro]: Status of PIO: Jonathan has sent an email to Bill Lang to see if he is still interested in the position. Bill said there may be a second applicant that he will try to find the contact information for.

## **New Business:**

- [Wade] Approve ANPR FY2025 Budget: Budget (revised version) was distributed to the BOD for review and approval. Motion to approve needed. Rick H. made a motion to approve the 2024-2025 (April 1, 2024-March 31, 2025) budget, Lauren seconded. Discussion: Bill said it isn't ideal and too much trouble with IRS forms, so works. Vote: Passed unanimously
- [Wade] BOD preference for proposals for RR48 2025: Analysis of proposals so far received was distributed to the BOD. Discussion: Bill requests some input from the board. Rick. H. said the Kentucky site is a bit tired and he would not recommend it. Shannon said she thinks the WV state parks are fairly nice, or one of the more urban ones because of the amenities, which will be better/airport adjacent. Rae said in her experience, transportation is important. Lauren said leaning toward Charlotte would be her pick. Bill will be looking at WV State Parks and Charlotte.

# Education and Training:

- Manage training and education: Continuing with RR47 workshop offerings made contact with numerous possible workshop facilitators/instructors for RR47, none confirmed and others under consideration. Newsletter article for potential workshops and additional suggestions including a facilitator/instructor. Targeting end of April for final list.
- Manage mentoring program: new mentor-mentee partnership; averaging one every month. Continuing to reach out to mentors.
- Community outreach: 2025 offer for tabling event at National Cherry Blossom
   Festival sometime in March or April (timing peak cherry tree blooming dependent).
   Tabeling held on NPS site National Mall and Memorial Parks. Tables, chairs, tent
   covering are provided. Event draws thousands of visitors. Site has 230 park
   employees. There are ANPR members in the area. Would need to get ANPR material
   to site.
- Use of technology in education: Newsletter article soliciting program ideas/presentations/ facilitators for 60 -90 minutes using digital format - Zoom.

## Fundraising Activities:

- o No Report
- Executive Director and RR Manager:
  - Manage budget for FY2025: Budget submitted for approval. Melissa has very generously offered to manage the super raffle in the absence of input from Wendy Lauritzen.
  - Manage finances for ANPR: February financials sent to BOD. Worked with Harwell on the finances and Quickbooks.
  - Manage RR47 in Rapid City, SD: Management team meeting monthly now. Presenter applications are now being accepted. Pflaum, Wilson and Richards are moving ahead with the RR program.
  - Sign contract for venue for RR48: Analysis of proposals received sent to BOD for review and expression of preference for moving forward.
  - Seek venues for RR49 and RR50: No specific action so far.
  - Develop and manage contracts for Business Manager/Ranger Editor for FY2025:
     Contracts for Melissa have been reviewed and signed and will be effective
     Apr 1, 2024 .
  - Manage ANPR/Royal Caribbean cruise program: Still some openings, but getting close to deadlines for the earlier cruise dates. Thirteen cruises have been booked by ANPR members.
  - Melissa is Managing ANPR Super Raffle program: Plan to open for ticket purchase by
     May 15, 2024 . All BOD should look at significant contributions for the Super Raffle.

# • Business Manager and *Ranger* Editor:

- I did not make any progress on my Ranger editor goals as far as strategic planning, as mid-February/mid-March is a busy production month. April will be more conducive to spending time on my goals of improving planning and getting the (an) editorial board to engage.
- We have had two posts on the website in March, and I had hoped to have four posts
   one per week. This content comes from members, so please send me items to list
   and I will do so. I have had to press releases submitted by the Board.

- Assist with planning of RR: I'm helping out and on task with this goal, opening up registration three months early, creating the welcome letter, writing content for the magazine and working on the Super Raffle.
- o I have an article in *Ranger* asking for membership directory buyin, and I hope it will help me reach this goal as well.

## Committees and Task Groups:

- International Liaison (Weesner): Meg has distributed the plan to take applications for WRC scholarships and the committee to review them and make selections.
   Information will be included in the member newsletter and posted on social media.
- Ranger Museum (Mossman): looking forward to the article about the Museum and looking for donations to the Museum exhibits. Paul Anderson is leading the fundraising effort of \$200K. Currently \$1.3K has been collected so far.
- Yount Award (Townsend):
  - [Wade]: A Yount bust we ordered (to be "on hand") was shipped to my house in Marana by Art Castings of Colorado, and has been received, pending any decision about when to award it. JT Townsend is doing an update to the narrative and application process. This is a "Lifetime Achievement" award not an annual award. Would be relevant to know what other national awards exist to know which one is most appropriate to nominate people to. Discussion about all/any NPS disciples being able to apply because all employees are "Rangers" in the spirit of rangering and maybe Public Service. NPS does not do a Lifetime Achievement award. There are Freeman Tilden Award (interp), Crystal Owl Award for Education (L&D), NPCA Mather Award, Harry Yount Award, others?
- Investment (Wade): "Re-balancing" the allocations in the account has taken place to meet the approved Investment Policy Statement.
